NMED Revises Petroleum Storage Tank Regulations

The New Mexico
Environment Department
(NMED) published revised
Petroleum Storage Tank
(PST) regulations that
became effective on March
17, 2012. The main
changes were to rules on
equipment, testing,
operating practices, and
enforcement, but there
were many changes
throughout the rules.

The exemption for emergency generator tanks was eliminated. Now, emergency generator tanks systems must be registered by June 15, 2012.

Several regulations have been added for aboveground storage tanks (ASTs). A list of elements for AST installation including concrete foundation, support, and secondary containment are included.

Several release detection provisions were changed in the revised rules. New and replaced underground storage tanks (UST) installed after April 4, 2008 must use interstitial monitoring for release detection. Older systems installed prior to April 4, 2008 may continue to use monthly inventory control with tank tightness testing. Options for visual inspection of double walled-walled and double-bottomed ASTs were clarified and revised. Report requirements for annual



line leak detector testing are provided. Emergency generator tanks are exempted from the release detection requirements.

Several rules regarding corrective action were changed. The NMED Petroleum Storage Tank Bureau (PSTB) has oversight responsibilities for all tank cleanups no matter the source of funds whether from the Corrective Action Fund, an owner or other source. PSTB approval is required before a tier evaluation or risk assessment can be conducted. The requirement for drilling into groundwater for all site investigations was eliminated. A vapor mitigation standard of 10 percent of the lower

explosive limit was established and meets the Occupational Safety and Health Administration Standard.

Other revisions included: (1) a certified tank installer is not required for closure; (2) the certified installer renewal process has been streamlined; (3) the threshold soil standard for releases was revised; and (4) Operation and Maintenance Plans for unmanned facilities may be kept at an alternate location.
