Extreme Drought Conditions Continue In New Mexico

Do you remember the last time it rained? Was it September? It can be hard for us New Mexicans to relate to the horrible rains and floods experienced by residents of New Jersey and New York while we sweep the windblown dust from our homes and patios.

How bad is this drought? According to the National Weather Service, October 2012 was among the top 10 driest Octobers recorded since 1933 in Albuquerque. In comparison, no rain was recorded in October 1952. October 1975, 1995, and 2012 each had a trace of moisture. Similar conditions occurred this October throughout the rest of New Mexico with only a few communities (Clayton,

Los Alamos, and Roswell) receiving more than an inch of rain during October.

As mentioned in a November 3rd Albuquerque Journal article, the Albuquerque Bernalillo County Water Utility (ABCWUA) continues to ask their customers to reduce their water use since only 5 inches of rain has been received this year (although this year's monsoon was highly variable across the Albuquerque metro area). Customers have responded by using 250 million gallons less water than last year at this time. ABCWUA recommends watering just once a



week this time of year and stop watering once overnight freezing temperatures begin.

This has not been a good one to go boating at the reservoir. Navajo Reservoir, along the San Juan River in northwestern New Mexico, is just 65% full according to the University of Arizona's Climate Assessment for the Southwest. Even worse conditions occur along the Rio Grande in southern New Mexico. Elephant Butte Reservoir is at 5% of capacity, and Caballo Reservoir is at 4% of capacity. Cochiti Lake and Abiquiu Reservoir were the only New Mexico reservoirs that increased water storage during August.

Much of the country has similar conditions. The National Climatic Data Center reports that 37% of the country is experiencing severe to extreme drought conditions based on the Palmer Index. The drought has been most pronounced in the Midwest and Southwest. The dry conditions are expected to persist, but the areas affected may change.
